- 2) The students other than the state of Maharashtra shall have to pay two times of the tuition fee.
- 3) The fees other than Tuition fees will be increased after every two years by 10%(year 2014-2015 as base year)
- 4) The facilities fee for U.G. & P.G. shall have to be utilised for providing Hi-tech facilities such as Advance teaching aids like L.C.D. projector, Slide projector, video conferencing, internet, etc. to make teaching and learning process more effective.
- 5) The University share from the fees prescribed for Environmental Studies shall be Rs.65/- Out of Rs.135/-. This fee shall be charged to Part-II students at under graduate level.
- 6) Wherever the Govt. prescribed fee under a particular item/head and University prescribes the fee under similar head or item, the college/institute will charge only the fees prescribed by the State Govt. or any other competent authority of Govt.
- 7) If the students from Grant in aid course chooses one or more subject from Non Grant in aid course then 1/3 (one third) of tuition fee and laboratory fee will be admissible to the College from Non Grant in aid fee schedule.
